Louisiana Voter Registration Facts

To register to vote in Louisiana, you must:

- be a U.S. citizen
- be at least 17 years old, and turn 18 prior to the next election
- not currently be imprisoned, on probation, or on parole for a conviction of a felony
- not be under a judgment of mental incompetence
- reside in the state and parish in which you seek to register
- be registered 30 days prior to an election to be eligible to vote in the particular election
- bring a picture identification card to the polls
- if you don't have an ID, you can sign an affidavit at the polls

In Louisiana, your right to vote is restored automatically upon final discharge for all periods of probation, parole and imprisonment regardless of what jurisdiction the conviction occurred or whether or not it is a felony.

If you are incarcerated as a result of a felony conviction, you cannot vote in Louisiana. If you are a resident of another state who is temporarily incarcerated in LA, review your home state's laws.

You can register to vote at the Registrar of Voters office (in City Hall), Department of Motor Vehicle offices, Department of Social Services offices, WIC offices, Food Stamp offices, Medicaid offices and Armed Forces Recruitment offices.
